Craft Rock Ale

A strain characterized in collaboration with the "Brewing Sciences and Fermentation Technology" department of the Meurice Institute in Brussels. ROCK is the result of a rigorous selection of brewing yeast strains. It has fast fermentation kinetics and leaves little residual sugars. It produces notes of banana and spices, and has a low sedimentation rate, making it the yeast of choice for wheat beers, and 'Saison' beers. ROCK excels in the production of light and refreshing beers. This product complies with current EU regulations. The purity and quality of this product are verified by a specialized laboratory.

RECOMENDED DOSAGES

- Primary fermentation : 50-100 g/ hl
- Optimal fermentation temperature : 15-25°C

INSTRUCTIONS FOR USE

- Add the necessary amount of yeast into 10 times its weight in water or sterile must at 30°C. Mix gently and leave to rest for 15 min.
- In order to ensure a correct yeast metabolic activity, lower the temperature of the starter by adding an equal volume of water or sterile must.
- Wait 5 minutes and, if necessary, add again the same volume of water until the temperature difference between the yeast and the fermentation tank is less than 10°C.
- Add the yeast to the fermentation tank.

STORAGE

- Bottled under protective gas cover. Keep sealed in original packaging in a cool (<10°C), dry place.
- Respect the optimal use-by-date appearing on the conditioning.
- Remove air and close immediately once opened, should then be kept at 4°C for up to 7 days after opening.

- 100 g package
- 2 kg box (4x500 g)
